90-day trial period. A trial period can be useful for both employers and employees in ensuring that the role and the company is appropriate for both parties.

Both parties must agree to the trial period. The trial provision must be a written provision in the employment agreement. The trial period must not exceed 90 days, but it could be for a shorter period than 90 days. During the trial period the employer may dismiss the employee by giving notice of termination.

A trial can be a maximum of 90 calendar days, less if you choose. There is no ability to extend the trial period past 90 days. The Employment Agreement should state that the trial starts from the work commencement date and state what date it finishes.
