Individuals, including sole proprietors, partners, and S corporation shareholders, generally have to make estimated tax payments if they expect to owe tax of \$1,000 or more when their return is filed. Corporations generally have to make estimated tax payments if they expect to owe tax of \$500 or more when their return is filed.

For calendar year filers, estimated payments are due April 15, June 15, and September 15 of the taxable year and January 15 of the following year. If you file your income tax return by January 31 of the following year and pay your entire balance, you do not have to make the January 15 payment. If you do not make the required estimated payments you will owe interest for underpayment of estimated tax.
