Three-Day Notice to Pay Rent or Quit. As soon as a tenant fails to pay rent, a landlord can give the tenant a three-day notice. This notice must inform the tenant that if the tenant does not pay rent within three days of receiving the notice, then the landlord will begin eviction proceedings against the tenant (see Cal. Code of Civ. Proc. 1161(2)).
